## Corrigendum

The result of the interviews for the posts of Medical Officer (Ayurved), Guj. Ayurved Service, Class- II, Advt. No. 178/2007-08, were held from 12/04/2010 to 30/04/2010 (Total 15 days), declared by the Commission on 26<sup>th</sup> May, 2010.

Hon'ble High Court has directed the Commission in SCA No. 4453 of 2012, to include the names of petitioners in the select list and place them at appropriate place, keeping in view the decision of the Supreme Court of India in the case of Rajesh Kumar Daria V/s.
