The following **292** candidates are declared provisionally qualified in the Combined Competitive (Preliminary) Exam conducted by the Gujarat Public Service Commission on 26.02.2017 for the post of **Municipal Chief Officer, Class-II (Advt. No. 65/2016-17)**. The provisionally qualified candidates are declared eligible for appearing in the Main Written Examination, subject to their fulfilling all conditions of eligibility of Advt. No. 65/2016-17.

In accordance with the rules of the examination, all these candidates have to apply again for admission to the main examination in the detailed application form, as per the instruction of the commission. For the purpose the public advertisement will be given and the candidates will have to apply within the stipulated time.

2. Details of Category wise marks obtained by the qualified candidate and Category wise total candidate are shown below:

Note:-

- (1) Cut-off marks means marks secured by the last candidate if merit list (arrangement of total marks obtained in descending order) of the concerned category.
- (2) As per the instructions of circular No. pavas-1099-mum-13-G.4, Dated: 29.01.2000 of General Administration Department, when Cut-off marks of reserved category candidates is higher than general category candidates, Cut-off marks of reserved category candidates should be lowered down to the Cut-off marks of General category candidates. Accordingly, Cut-off marks of S.E.B.C.(Male), S.E.B.C.(Female) and S.C.(Male) category candidates is lowered down to the Cut-off marks of General category candidates in this result. Cut-off marks of general category (Male) candidates is 87 marks and Cut-off marks of General category (Female) candidates is 71 marks in this result, where Cut-off marks of S.E.B.C. (Male) candidates is 91 marks, Cut-off marks of S.E.B.C. (Female) is 79 Marks and Cut-off marks of S.C. (male) candidates is 88 marks. Therefore, Cut-off marks of S.E.B.C. (Male) and S.C. (Male) candidates have been lowered down to 87 marks and Cut-off marks of S.E.B.C. (Female) candidates have been lowered down to 71 marks which is equivalent to the Cut-off marks of General category (Male) and General category (Female) candidates respectively.
- (3) As per the instruction of circular No. CRR-1096-2213-G.2, Dated: 31.08.2004 of General Administration Department, result of the widow candidates is prepared after adding 5% of marks obtained by them.
