Note :- (1) The candidate at Rank No. 04 is selected by relaxing the minimum qualifying standard prescribed for the General Category candidate.

(2) With regard to women reservation as provided for in the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2, dated 9th April, 1997 and GAD Circular No. CRR/1096/2213/G-2, dated 22nd May, 1997, 02 women candidates (General-01 and SEBC-01) are required to be selected. As against this, 01 woman candidate of General category at Rank No. 03 has been selected.

(3) 01 post of SEBC category remained vacant, as no suitable candidate was available and also 01 post of ST category candidate remained vacant, as no candidate was available for the interview.

(4) In case of equal marks the merit is assigned taking into consideration the date of birth (i.e. preference is given to the elder) and as per the O.O. No. REQ-1088-42-R&D, dated 8/12/2011 and 16/7/2015.
