Note :-

- (1) As per the direction of the Hon'ble High Court in M.C.A. No. 01/2018 in S.C.A. No. 18303 to S.C.A. No.18306 with S.C.A. No. 21549 to S.C.A. No. 21555 of 2017, the Commission had conducted Preliminary Test after the completion of interviews in October, 2017.
- (2) 01 post of SEBC and 1 post of General category remained vacant, as no candidates were available for the interviews.
- (3) 01 post reserved for Disabled candidate (Advt. No. 01/2017-18 to 14/2017-18) remained vacant, as no candidate was available for the interview.
- (4) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks

- (5) As per O.O. No. રૂ મગ-૭૫૧૪-૨૦૧૪-અર એનસી dated 20-04-2018, if any candidate remains absent at any stage of the recruitment process, then his/her candidature shall be cancelled. As Dr. Satyendra Kumar Kamla Kant Tiwari, bearing E.No. 02, remained absent in Interview Test, he has not been considered eligible for the selection.
- (6) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. Nos. 13617, 13618, 13619, 13620, 13621, 13622, 13623 and 13624 of 2017.
