Note :-

- (1) 02 posts of Disabled category remained vacant (Advt. No. 50/2017-18 to 63/2017-18), as no candidates were available for the interviews.
- (2) The candidates at Merit No. 1, 2 and 3, possess post graduate degrees in concerned subject (Rog Nidan and Vikriti Vigyan) while the unsuccessful candidate, bearing E.No. 20, possesses a post graduate degree in allied subject (Kaya Chikitsa), hence the candidates at Merit No. 1, 2 and 3, have been preferred for selection, as per the provisions stated in rule 3 (b) of the recruitment rules.
- (3) The SEBC Category candidate kept at serial No. 02 on waiting List for SEBC category, though possesses a post graduate degree in allied subject (Kaya Chikitsa), has been considered for waiting list, as no other SEBC category candidate is available with a post graduate degree in concerned subject (Rog Nidan and Vikriti Vigyan), as per the above stated rule 3 (b).
- (4) The Weighted Marks of Preliminary Test & Interview are calculated as follows :-
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
- (5) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. No. 23177/2017 and other related matters.
