#### **Note :-**

- (1) As per the direction of the Hon'ble High Court in M.C.A. No. 01/2018 in S.C.A. No. 18303 to S.C.A. No.18306 with S.C.A. No. 21549 to S.C.A. No. 21555 of 2017, the Commission had conducted Preliminary Test after the completion of interviews in October, 2017.

- (2) The Cut-off Marks for General Male Category derived is 55.20 marks and after subtracting 10% Marks from the Cut-off Marks, the Cut-off Marks for the consideration of General-Fem. Category candidate is derived at 49.68 Marks (i.e.  $55.20 - 5.52 = 49.68$  Marks). No General-Fem. Candidate with equal or above Cut-off Marks is available. Hence, the next meritorious candidate available has been taken into consideration for selection and the new Cut-off Marks for Male, derived is 52.16 marks. After subtracting 10% Marks from the Cut-off Marks, the Cut-off Marks for the consideration of Female candidate, is derived at Marks (i.e.  $52.16 - 5.22 = 46.94$  Marks). As 01 Female Candidate above the Cut-off Marks derived is available for selection, is selected at Merit No. 03, for recommendation for appointment to the Government and the Male candidate taken into consideration for selection, is kept on Waiting List at Serial No. 01.
- (3) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**  
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
- (4) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. Nos. 13617, 13618, 13619, 13620, 13621, 13622, 13623 and 13624 of 2017.
