 - B. Candidate who desires to obtain the Mark-sheet of the Main Examination shall apply to the Commission along with such fees as may be fixed by the Commission **within a period of 15 days from** the date of declaration of the final result of the Main Examination i.e. subsequent to Viva-voce.
