### **Note :-**

- (1) As per the direction of the Hon'ble High Court in M.C.A. No. 01/2018 in S.C.A. No. 18303 to S.C.A. No.18306 with S.C.A. No. 21549 to S.C.A. No. 21555 of 2017, the Commission had conducted Preliminary Test for the recruitment to the above posts on 06th May, 2018, though the interviews were held on 10th October, 2017.
- (2) 01 post of SEBC and 01 post of S.T. category remained vacant, as no candidates were available for the interviews.

- (3) 01 post reserved for Disabled candidate (Advt. No. 01/2017-18 to 14/2017-18) remained vacant, as no candidate was available for the interview.
- (4) As per Office Order No. PTG-APF-888-Part-2-R&D, dated 26th November,2014 10% marks of the total marks of the preliminary test (i.e. minimum qualifying standard) has been fixed as eligibility criteria to qualify for interviews. E.No. 07 has not been considered eligible for selection as he has obtained less marks than the minimum qualifying standard in the preliminary Test though he was called for interview held before the preliminary Test.
- (5) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**  
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
- (6) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. Nos. 13617, 13618, 13619, 13620, 13621, 13622, 13623 and 13624 of 2017.
